Facts Causing a collision with car Nr 31 (driver Roberto GONZALEZ)
Offence Appendix L, cap.4, Art. 2.d of ISC
Penalty REPRIMAND

Reason After hearing the two drivers concerned and watching the video of the incident the stewards considered that the car Nr 31 had already overtaken car Nr. 50 when the contact happened. Consequently the stewards considered that the collision was avoidable on behalf of car Nr. 50. Due to the fact that it is the first race in Lmp2 and in the WEC for Driver Ricci the stewards decided only to reprimand the driver. The stewards draw the driver attention to the fact he has to leave the room in a polite manner.

Facts Incorrect declaration of Fuel Flow Meter
Offence Art. 6.1.4 of Sporting Regulations
Penalty Cancellation of all lap times achieved in qualifying session
Will start the Race from the Pit lane and shall not join the race until the last car in the field has covered his first lap and following Race Director instruction

The competitor was granted a hearing and being summoned he reported on time.

Reason

During the hearing the competitor accepted the fact stated in the Technical report Nr. 6. Consequently the car didn't comply with the equipment declaration form and the laps times have to be cancelled.
For safety reason the stewards decide that the car has to start from the pit lane in conditions described in Art. 10.7.4
