**No** 70 – Eddie CHEEVER  
**Competitor** MR RACING  
**Session** Test Day 24 Hours of Le Mans  
**Time** Administrative checks on Friday, 1<sup>st</sup> June  
**Facts** Late arrival for Administrative checks and briefing  
**Offence** Breach of Art. 5.2.1 and Appendix 1, Art. 12.3 of the 24 Hours of Le Mans Regulations  
**Penalty** Fine of € 500,-  
**Reason** The driver explained that he was coaching a client racing in Blancpain Series at Paul Ricard. The stewards decided that this commitment couldn't be considered as a instance of force majeure allowing the driver to arrive late at the administrative checks of the Test Day .

The Competitor is reminded of his right of Appeal under and in compliance with Art. 4.11.2 b of the Sporting Regulations, Article 14 of the International Sporting Code, and Art. 12 of the Judicial and Disciplinary Rules of the FIA.
