The Stewards, having received a report from the Technical Delegates and hearing the manufacturer representative Mr. Mondain in presence of the FIA Technical Delegate Manuel Leal and the ACO Technical Delegate Thierry Bouvet, have considered the following matter, determine a breach of the regulations has been committed by the event participant named below and impose the penalty referred to.

Event participant MICHELIN represented by Mr. MONDAIN Time before Scrutineering Facts Did not declare the tyre references to the Technical Delegates 48 hours before the event Offence Breach of Art. 7.7.1 of WEC Sporting Regulations Penalty Fine € 5.000 thereof € 4.000 suspended The suspension shall be revoke for another declaration infringement by the tyre manufacturer during the Superseason 2018 – 2019

Reason The representative of Michelin agreed with the report of the Technical Delegates that the final list of tyres eligible for the event TOTAL 6 hours of Spa, starting on 2nd May 2018, has been declared on 3rd May 2018 at 10:35. Mr. Mondain explained that it was not possible in the factory to identify the tyre by RFID but only by barcode. Arriving in Spa Michelin realized an error in the amount of tyres and a difference of the accordance of RFID and the barcode. Due to the correction the final list has been declared so late. The late declaration delayed the planned schedule of the scrutineering and the scanning of the tyres by the scrutineers. In accordance with Art. 1.3. FIA WEC Sporting Regulations and Art. 1.3. International Sporting Code Michelin is considered as a Participant of the event and undertake himself to the decisions of the Sporting authority

The Competitor is reminded of his right of Appeal under and in compliance with Art. 4.11.2 b of the Sporting Regulations, Article 14 of the International Sporting Code, and Art. 12 of the Judicial and Disciplinary Rules of the FIA.
