Facts Failed to declare Test session by Deadline
Offence Alleged Breach of Art. 9.2. of WEC 2018-2019 Sporting Regulations
Decision No further action.
Reason The competitor failed to declare a rollout day in advance. However, when discussing the case with the technical department, the competitor elected to classify the test as a Private closed test day and was therefore eligible to declare this within five days, which he duly did. Therefore, the Stewards found that there was no breach of the regulations, and that the competitor used one Private closed test day.


