The Stewards, having received report Nr. 01 dated June 11<sup>th</sup> 2018 from the FIA Technical Delegate, mentioning the commitments of Michelin (letter from May 25<sup>th</sup> 2018) have considered the following matter.

**Event Participant** MICHELIN Company, known as MICHELIN Motorsport, Societé en commandite (RCS Clermont Ferrand 855 200 507, Place des Charmes – Dechaux Clermont Ferrand 63040, France)

**Time** WEC Superseason 2018 - 2019

**Facts** Lack of supply the number of tyres in duly specifications mentioned in the WEC 2018-2019 Sporting Regulations

**Offence** Breach of Art. 7.7.2 of WEC Sporting Regulations

**Decision** Amendment of Stewards decision n°20 SPA 2018  
 € 200.000 suspended to the missing quantity of tyres is delivered at the latest 24 hours before Silverstone event 2018

**Reason** Regarding the MICHELIN's commitments taken in the letter on May 25<sup>th</sup> to ACO and FIA sporting directors and the report of the Technical Delegates, the proposal from Michelin ensures that until the end of the 2018/2019 season the stability of the tyre specifications as intended as in Art. 7.7.2. of the WEC Sporting Regulations is guaranteed.

**The Competitor is reminded of his right of Appeal in accordance with Article 15 of the FIA International Sporting Code and Article 19.1.1 of the FIA Judicial and Disciplinary Rules.**
