To The Manufacturer's Representative
MICHELIN – Mr. Jerome Mondain

The Stewards, having received report Nr. 3 from the Technical Delegates and hearing the manufacturer representative Mr. Mondain, have considered the following matter, determine a breach of the regulations has been committed by the event participant named below and impose the penalty referred to.

Event participant MICHELIN represented by Mr. MONDAIN Jerome
Time June 11th 2018 at 21.14
Facts Did not declare the tyre references to the Technical Delegates 48 hours before the event
Offence Breach of Art. 7.7.1 of WEC Sporting Regulations
Penalty 1) Withdraw the suspension of decision Nr. 18 (Spa) and order the payment of the suspended € 4000
2) Fine € 5.000 suspended
The suspension shall be revoke for another declaration infringement by the tyre manufacturer during the Superseason 2018 – 2019
Reason The tyre manufacturer Michelin declared the list of tyres after the deadline. As is a repetition of the offense in Spa, the suspended penalty from Spa has been applied. With respect to the new violation the Stewards acknowledge the efforts of the manufacturer and the large quantity of tyres that need to be produced and therefor suspended the entirety of the new penalty.

The Competitor is reminded of his right of Appeal in accordance with Article 15 of the FIA International Sporting Code and Article 19.1.1 of the FIA Judicial and Disciplinary Rules.
