N°44 – EURASIA MOTORSPORT

The Stewards, having received a report from the **Technical Delegates** (Report Nr. 7), heard from the driver and competitors representative, have considered the following matter, determine a breach of the regulations has been committed by the competitor named below and impose the penalty referred to.

No, Driver N° 44 – Tracy KROHN
Competitor EURASIA MOTORSPORT
Time 23:17:15
Facts The driver didn't stop at the scrutineering light for weighing during qualifying practice 1
Offence Breach of Art. 6.9.5 of the 24 Hours of Le Mans Specific Regulations
Decision Fine of € 1.000 and deletion of all the laptimes of the car up until the time of the infraction
Reason The driver of car 44, Tracy Krohn, admitted to the Stewards that when entering the pit lane he was distracted by his radio system and did not see the light displayed by the technical delegates which requires him to stop for weighing. This is a breach of Art. 6.9.5 of the specific regulations for the Event. This article refers to a € 1.000 fine and further penalties referred in Art 6.9.7. In the Specific Regulations, there is no such article. However, the traditional penalty for this beach has been to delete the times up to the time of the infraction, in addition to a fine This ensures that any time set when a car was possibly underweight is not counted. This is foreseen in Art 6.9.6, and the Stewards are aware that this is a numbering mistake in the regulations. In order to ensure the integrity of the competition, the Stewards therefore use their authority under Art 11.9.3.a of the International Sporting Code to decide what penalty to enforce in the event of a beach of the regulations, and therefore order the penalty referred to above.

The Competitor is reminded of his right of Appeal in accordance with Article 15 of the FIA International Sporting Code under and Article 19.1.1 of the FIA Judicial and Disciplinary Rules.

We remind you that it has to be paid to the FIA **48 hours as from the present notification**. (cf. Article 12.7 of FIA International Sporting Code) on the following bank account with specified motive on your transfer :
