

**Competitor** PORSCHE GT TEAM  
**Time** 18:10  
**Facts** Driver left the pit with the safety belts loose  
**Offence** Breach of App.L of ISC, chap.3, Art.4 and Art. 10.8.1.14 of WEC Sporting Regulations  
**Penalty** Drive through penalty suspended and fine of € 50.000 suspended  
Suspension shall be revoke for the same or similar safety infringement by the driver until the end of the Superseason 2018/2019.  
**Reason** The driver was observed placing his belt on his HANS-device and tightening the belts well after leaving the pits. This is considered dangerous.
