The Stewards, having received a report from the Technical Delegates (Report Nr. 9), summoned and heard the Team representative from Team Project 1, the Manufacturer Representatives Pascal Zurlinden und Robert Kübel and the Technical delegates and having considered the matter, determine that a breach of the Regulations has been committed and impose a penalty referred to

**Manufacturer** PORSCHE AG

**Time** Post-Qualifying Checks

**Facts** Car is non-compliant with the homologation form

**Offence** Breach of art. 6.1.4 of the WEC Sporting Regulations

**Decision** Fine of € 25.000,-

**Reason** The stewards consider that Porsche AG as participant of the competition (Art. 1.3.4. of the WEC Sporting Regulations). Porsche AG informed the FIA and ACO during the Prologue in Barcelona (21.-24.7.2019) that they are preparing an Erratum to the Homologation Form GTE\_PORSCHE\_911 RSR 2017\_17-1-Errs-30. The Erratum was valid from 01.08.2019. Porsche AG did not forward the updated homologations papers or the relevant parts to the competitors. The representative from Porsche AG admitted that it was the fault of Porsche AG and explained that they had not enough parts for delivery to their customers but forgot to inform the FIA or their customers. The stewards accepted the explanation from Porsche AG and remind Porsche AG that all customers cars must be equipped with the relevant parts for the next race of the championship.

**The Competitor is reminded of his right of Appeal in accordance with Article 16.1.6 of the FIA International Sporting Code and Article 12 of the FIA Judicial and Disciplinary Rules of the FIA.**


