At the Post-Qualifying technical checks the minimum ground clearance has been found lower than 50mm which is a breach of the Technical Regulations. The Stewards decide to disqualify the car and as a consequence give the permission to start the Race from the back of the grid with the driver who set the fastest time in Free Practice (Alessio Rovera)
