For safety reasons, the WEC Committee would like to clarify the article 12.2.2.d) of the FIA World Endurance Championship Sporting Regulations.

As Article 12.2.1 “For personnel working on the car: the presence of equipment and personnel in the working area is only authorised when the car is present, and its engine is off.” Must be respected at all time during a pit stop, the WEC Committee finds clearer to delete the last sentence of article 12.2.2.d) as follow:

12.2.2 Pit stop procedure

(...)

d) Departure of the car from the working area

A car controller is responsible for allowing the car to leave the working area safely.

~~All persons permitted in the working area must return promptly to the garage after the car departs.~~
