The Stewards, having received a report from the FIA Technical Delegate, summoned and heard the driver and team representative, have considered the following matter, determine the following:

<b>Competitor</b>	GOODYEAR RACING EMEA
<b>Session:</b>	Before the start of the event
<b>Fact:</b>	Didn't declare list of tyres in time as per Art. 6.5.1 of WEC Sporting Regulations
<b>Offence:</b>	6.5.1 of WEC Sporting Regulations
<b>Decision:</b>	A fine of € 30.000 payable as follows: € 5.000 to be paid immediately € 25.000 suspended provided that by the end of the 2022 WEC season the competitor does not commit a new offence of Art. 6.5.1

**Reason:**

Goodyear as tyre supplier is considered as a competitor following the provisions of Art. 1.3.4 of WEC Sporting Regulations. The Stewards received a report (Tech. Report Nr. 2 ) from the Technical Delegates, and summoned and heard the Competitors' representative Mr. Mike McGregor, who recognized that he didn't declare 48 hours before the beginning of the competition the correct list of references of tyres for identification by RFID and barcode.

The correct list was declared to the Technical Delegates on Saturday 9th July before the Qualifying sessions.


