# Modification of the Appendix 11 article 2.7 of the 2023 FIA World Endurance Championship Sporting Regulations

Michelin is kindly requesting to modify the article 2.7 by deleting the following sentence "*Tyres must* not be carried over from one day to another, regardless of the type of test the tyres will be allocated to, excepting Endurance Tests, which shall be considered one day per 2.5."

The tyre test quantities limited to 6 set per day with <u>no carry over</u> makes difficult to manage it and doesn't go towards a reduction of costs as some tyre sets will have only a very low number of laps and couldn't be reuse on another day. Our proposal is to manage the limitation of the tyre quantities per test session and not per day based on the limitation of 6 sets per day (eg. 3 days test = 18 sets maximum to be used).
