### **APPENDIX 7, Article 3.: PERONNEL LIMITATION states :**

3. Non-operational staff (without seat)

The personal listed below constitute exemptions to Article 2, but cannot benefit from a seated position with / or without a laptop in one of the technical spaces attributed to the Competitor

- Hospitality, motorhomes and catering personnel
- Logistic coordination
- Sponsors, marketing, media and public relations personnel
- Security personnel and truck drivers, to the extend they have no role (e.g.: rim and tire handling) during the competition
- Drivers and their medical staff
- Tire engineers assigned by the manufacturer, limited to one person per car

### The personal listed below find it to difficult to complete their tasks without a seated position and without a laptop:

- Hospitality and catering personnel (needs a place to work / to stay in touch with the local catering, catering-staff, cleaning staff, security, completing delivery notes, adapting number of meals, paying invoices on-line, etc.)
- Logistic coordination (needs to book / re-book flights, arrange rental-cars or taxis during / after the races, etc.)
- Sponsors, Marketing, Media / Press, Business relations personnel (needs a place to work / to stay in touch by e-mail with arriving sponsors, arrange shuttles, hotel reservations / cancelations, arrange / schedule interviews, coordinate camera-men's / social media staff's, prepare press-releases, etc.)
- Drivers and their medical staff (needs a place to work on their social media platforms, prepare their next travels, review regulation's, Doctors needs a place to work / medically examine drivers / Team-

members, coordinate additional doctors working in parallel at another place but belonging to the same Doctor-Team.

Therefore we, Porsche Penske Motorsport kindly ask the WEC Committee permission for creating a "**NON-TECHNICAL SPACE**", which could be a separate container, separate villa-area, separate amount of tables & chairs, within the entire space attributed to Porsche Penske Motorsport on track.

In this dedicated area will be no activity related to the car-operation during the event, just activity which belongs to the following personnel:

- o Hospitality manager, Hospitality-staff coordinator, local food-coordinator
- Logistics / staff travels
- Business relation / Marketing / Media / Press / Communication / Camera social media TV personnel
- Drivers / medical staff

#### COMMENTS (TO BE COMPLETED BY THE COMMITTEE)

Article 3 of Appendix 7 defined a list of staff as "non-operational staff (without seat)"; the article states that those people "cannot benefit from a seated position [...] in one of the technical spaces attributed to the Competitor." In that sense, those people can exceptionally benefit from a seated position with a laptop in non-technical spaces.

To separate technical from non-technical spaces, we expect the Competitor to demonstrate common sense. The garage being an entire technical space, then team villas or teams' hospitalities can be arranged to separate technical and non-technical area. For example, if any person is find using an intercom radio or an operational software, this person will be considered as operational staff wherever its seated position is located.
