**Reason:**

The Stewards reviewed the car data, which confirmed that the driver failed to reduce speed despite having been informed that he was in a yellow flag zone. Accordingly, the Stewards determined that the driver committed a breach of the yellow flag regulations.

According to Art. 12.3.4 of the FIA International Sporting Code and the article 7.4.6 of 2025 24 hours supplementary regulations, this decision is not subject to appeal.
