Decision: Fine of € 2000

Reason:

After examining the report from the Timekeeper, the Stewards noted that Cars 3, 14, 43, 59, 74, 77, 87, 93, 94 went on the track with a different transponder than the one declared, and that no declaration of such change had been submitted prior to the start of the FP1 Test Day.

In accordance with the applicable Sporting Regulations and due to the absence of the required declaration, the Stewards hereby impose a fine of €2,000 on Cars 3, 14, 43, 59, 74, 77, 87, 93, 94.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
